It goes without saying that each one of these tools is changing lives in a multitude of ways, but we can't help but appreciate that starts right here at home with our donors, supporters, and of course volunteers. Throughout the year our Rockville warehouse stayed busy every week. Our small staff was amplified by dedicated volunteers who allowed us to process and donate a record number of bikes this year. Over 2,000 volunteers grabbed wrenches and logged over 7,000 hours- that's even more hours than our staff worked this year combined! We hosted 60 school, civic, and corporate groups in the warehouse giving them the opportunity to work with their hands, learn more about bikes, and stretch their impact to make a difference around the world. At our remote collection events we joined forces with over 50 groups. And our Thursday night volunteer nights are growing in popularity. This all means that we donated nearly 13,000 bikes in 2025 and loaded 25 containers of bikes for overseas partners.
